The Zilinski Memorial Fund literally saved my life. I was stuck in a wheelchair and extremely depressed due to the poor condition of my legs. Doctors told me I couldn't be active because I couldn't risk damaging my fragile feet. They also said they wouldn't amputate until I had gangrene. The Fund paid for my surgeries and allowed me to have my life back. I now not only stand but walk daily, run 5k's and am a captain on the US Women's Para Ice Hockey team! The surgeries allowed me to turn my life around and pay it forward.

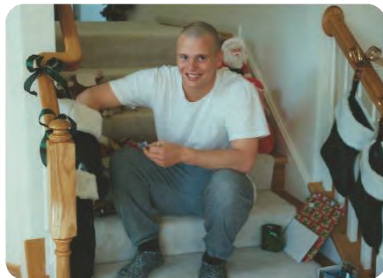

My wife and I purchased our home in upstate NY in 2015. Between March 8, 2017, and March 17, 2017 our area was hit with bad storms with winds peaking at 69.5 MPH that folded over a portion of our roof, curled and cracked many tiles. On March 10, 2017 another storm hit our area with rain and snow for two days, causing our roof to be exposed causing major leakage. At the end of the storm an emergency enclosure was completed on the missing tiles.

An insurance inspector came to our home and informed us that our roof “looked good” without even climbing a ladder to inspect it. Little did we know that the water intruded the tiles and damaged the whole roof. There was so much water that the venting system did not have a chance to dry it out completely. Since our attic is not a livable part of the home, we never went up there.

During the summer and fall of 2017 the weather was so wet and warm that the attic never dried out and created the perfect breeding ground for mold spores. My wife and my daughter became severely ill and could not remain in the home. The insurance company refused to assist us with the repairs to remove the mold and the replacement of the roof.

We attempted to receive help to save our home and were denied by many organizations until we contacted the Lt. Dennis W. Zilinski, II Memorial Fund. Mr. Zilinski contacted the mold remediation company and the roofer and made arrangements for the repair of our home. Without their intervention, our home would not be livable and we are extremely grateful.

Thank you to all who support this organization so that they can help warriors like me.

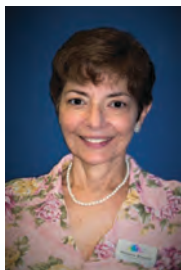
I am forever grateful for them and all the people who helped us reclaim our home.

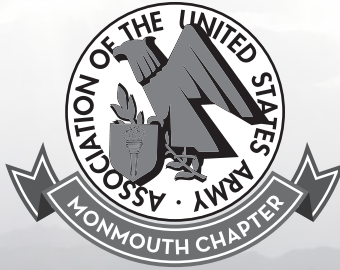
